Report of the INF-FNI WW-Assessor for the 2022 World Congress in Luxembourg (Period 2020 - 2021)

The WW Assessor - or Assessor for non-European countries - is a member of the Central Committee with responsibilities like any Central Committee member. In this capacity I enjoyed in particular being part of the small group of people from a range of federations which completed the task of polishing the Vision - Mission statement, that I and changing EU Assessors had been working on for several years, into the document we have today, which I believe will stand for many years to come.

Apart from being a CC member in general, the WW Assessor is in particular tasked with assisting federations outside of Europe and persons outside of Europe interested in creating a new federation - as well as any other issues they may have.

In this respect, I have successfully blocked a few attempts from people in countries with currently no federation in registering an ordinary membership of INF-FNI. These attempts were made by people without any connection to the majority of the naturists living in those countries. It would not have been so serious if it wasn't for the monopoly that we offer such ordinary members to be the only organization in that country that can sell INF-FNI stamps. This monopoly of selling INF-FNI stamps is a dangerous business when you consider countries the size of India and China with both over one billion people!

Recently, Senegal upgraded from a correspondent to a federation and is now registered as LES NATURISTES DU SÉNÉGAL.

Due to the Coronavirus epidemic, the two years 2020 - 2021 have generally been very quiet. Most positive development is that all federations have experimented with and many succeeded in developing new ways to stay in touch with their members online, when physical presence at clubs and resorts was restricted. I am especially fascinated with how the Australian Naturist Federation (ANF) has developed an online Pub Night and a video newsletter which is still outstanding and ready to be copied by any other federation.

The overall picture for federations outside of Europe is, though, that the Coronavirus epidemic was not beneficial for the number of members of the different federations. The only country which has expanded its memberbase significantly during the 2020 - 2021 years is Canada, where the two Canadian federations together have increased membership from 1000 to 1400 members.

As previously announced, I am stepping down from this position after five years as a CC member. I wish my successor all the best of luck.
