A conference on the challenges for naturism was held in parallel to the EuNat meeting in Bonn in March 2023.

Sönke Reise, chairman of [GetNakedGermany e. V.](https://www.getnakedgermany.de/), gave a presentation on "Challenges for naturism" and the conference then divided into three working groups.

Unfortunately, time did not allow for a formal presentation of the conclusions.

## Important information

Associations are reminded that following the decision of the World Congress adopted by EuNat, applications for subsidies for events should be decided on the basis of the following strategy.

- The general strategy should be that funding is primarily used to support the establishment of new naturist events.
- Events are eligible for subsidy when
  - They clearly promote naturism and participation in naturism, also by younger people
  - The event could not be held without a grant (proof would be required)
  - The event is open to international visitors (INF-FNI members)
  - The event is open to non-members (e.g. guests of members, people experiencing naturism for the first time).
- If a grant is awarded, this should be made clear, e.g. on promotional materials for the event
- These criteria would not immediately apply to events organised by federations on behalf of the INF (swimming gala, pétanque tournament), although in principle these events should be adapted over time.

**As was made clear at the EuNat meeting in Bonn in March 2023, the expectation is that repeated events will become self-financing over time.**

In order to enable EuNat to make an informed decision on subsidy requests, such requests should be submitted in the form of applications, including the decision requested, the arguments and the financial implications.

In particular, applications for subsidies should include the following:

- Date and place of the event
- Explanation of the event
- Own contribution of the Federation and expected number of participants
- Requested subsidy in €
- Confirmation and compliance with the existing regulations of EuNat
- Determining whether the action is a one-off or a repeated action
- Rationale for the subsidy

See also the paper “Using EuNat Funds to promote Naturism: A strategic Approach”, which sets out a proposed future approach. Those seeking subsidies for events should consider the questions set out under “Criteria for funding events” in that document.
